Project context



- We have used partial equilibrium techniques to estimate economic contributions, combined with data provided by the Port of Newcastle for 2018/19, and other public sources.




Economic contribution



PoN and its tenants contributed to \$1.5 billion of economic activity in Australia in 2018/19, and 9,000 jobs









